## FMT (Tourist Visa) & FM2 Information

<b>FM2 – New</b> Requirements	\$6300 pesos <b>1)</b> Original FMT or FM3 <b>2)</b> Passport <b>3)</b> 3 most current bank statements* proving minimum income of \$2000 USD per month (translated into Spanish <b>Note:</b> Please contact us for further information if you have a dependant <b>4)</b> Proof of address in your name** <b>5)</b> 6 front and 4 right profile pictures measuring 4cm x 4cm. Pictures must be taken with no jewelry or eye glasses, and your hair must be off your forehead and ears. Cannot be instant photo paper. <b>Note:</b> If you own property in Mexico, the monthly income requirements are reduced by half.
<b>FM2 – New w/work permit</b> Requirements	\$6300 pesos <b>1)</b> Same as new FM2 requirements + <b>2)</b> Letter from employer on letter head. If you are self-employed, a letter stating the activities you plan to do in Mexico <b>3)</b> A certified copy of said employers last tax declaration and a certified copy of Acta Constitutiva of the corporation <b>Note:</b> The letter must be written by a legal representative of that business, including copies of their ID. Also, the bank statements will NOT be required.
<b>FM2 – Renewal</b> Requirements	\$3800 pesos <b>1)</b> Passport <b>2)</b> FM2 <b>3)</b> 3 last bank statements* proving minimum income of \$1300 USD per month, and \$650 USD for each depend ant. <b>4)</b> Proof of address in your name**
<b>FM2 – Renewal w/work Permit</b> Requirements	\$3800 pesos <b>1)</b> Passport <b>2)</b> FM2 <b>3)</b> Letter from employer asking for renewal <b>4)</b> Proof of address in your name** <b>5)</b> Copy of employers I.D. <b>6)</b> The employers last tax declaration, or a certified copy
<b>FM2/3 address change</b> Requirements	\$500 Pesos <b>1)</b> Copy of new lease or deed <b>2)</b> FM2 or 3
<b>Permit to leave the country</b> Requirements	\$800 Pesos <b>1)</b> Passport <b>2)</b> Travel Itinerary or Tickets <b>3)</b> 2 “Credencial” size Photos <b>Note:</b> This is required if you need to leave Mexico while your FMT, FM2, or FM3 is being processed.

\*Must be originals, cannot be Internet prints , faxes or copies

\*\*Must be originals of your telephone bill, electric bill, lease, or deed
